UNDERWOOD CITY COUNCIL REGULAR MEETING MINUTES Tuesday, March 9, 2021

Call to Order: Mayor Dennis Bardsley called the meeting to order on Tuesday, March 9, 2021, at 6:00 p.m.

Pledge of Allegiance: Recited by all.

Approval of Agenda: Pingel moved, Tiarks seconded to approve the agenda. Motion carried 5-0.

Approval of Minutes: Madsen moved, Forbush seconded to approve the February 9, 2021 Regular Meeting minutes and the February 18, 2021 Special Meeting minutes. Motion carried 5-0.

Public Forum: There were no comments emailed or telephone calls received. Those in attendance were on the agenda.

Friends of Underwood – Request for Street Closures for Junkwood and Permission to add another Little Library on Hope Avenue: Madsen moved, Pingel seconded to approve the Little Library in the right of way, with the home owners approval and Friends of Underwood President to notify the City Administrator, who in turn will verify with the homeowner and determine approval prior to installation; and also to approve the street closures on 9/11/2021 for Junkwood on 3rd street (from Railroad Highway) to Century Link building on both sides of street, leaving handicapped parking spot and parking in front of Garcia's Restaurant (and other side of street – for restaurant clientele), and closing 2nd street in front of UMBA to 4th street by the Pavilion. Motion carried 5-0.

Re-set Public Hearing for Budget FY 2021-2022: Pingel moved, Madsen seconded to re-set the public hearing for Budget FY 2021-2022 for Wednesday, March 24 at 5 p.m. Motion carried 5-0.

Review/Approve Estimates for Fence Replacement and Repair at Lagoon: Pingel moved, Madsen seconded to approve DeVore Fencing for the fence replacement and repair at the lagoon for \$4,389.98. Motion carried 5-0.

<u>Review/Approve Estimates for Trailhead Park Bathroom Plumbing Repair</u>: Madsen moved, Forbush seconded to approve the estimate with Griffen Plumbing for \$420.00 and authorize City Administrator to move forward with any change orders up to \$1,000.00. Motion carried 5-0.
