Pingel moved, Tiarks seconded to set public hearing for September 13, 2022, at 6 p.m. Ordinance Sewer rates. Motion carried 4-0.

Pingel moved, Madsen seconded to accept Feed Lot Service Company quotation for demolition of city building at 625 Highway Street. Motion carried 4-0.

Madsen moved, Pingel seconded to approve Resolution 22-08-04 increasing mileage reimbursement rate to 62.5 cents/mile effective 8/1/2022. Roll Call Vote: Tiarks-Yes, Pingel-Yes, Dose-Yes, Madsen-Yes. Absent: Forbush. Resolution adopted 4-0.

Pingel moved, Tiarks seconded to approve the 9/1/2022 renewals for United Healthcare and Wellmark. Motion carried 4-0.
