AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF UNDERWOOD, IOWA, BY AMENDING PROVISIONS PERTAINING TO SEWER SERVICE CHARGE.

BE it enacted by the City of Underwood, lowa:

SUBSECTION AMENDED: Chapter 99, Section 02, of the Code of

Ordinances of the City of Underwood, lowa, is hereby amended to read in full as follows:

**(PROPOSED REVISION) 99.02 RATE.** Each customer shall pay to the City sewer fees as hereinafter provided.

1. Residential property owners shall pay a monthly charge based upon the amount of water consumed, including a 1,000-gallon minimum charge per property owner, as follows:
