UNDERWOOD CITY COUNCIL REGULAR MEETING MINUTES November 8, 2022

Mayor Dennis Bardsley called the regular meeting to order on Tuesday, November 8, 2022, at 6 p.m.

Pledge of Allegiance recited.

Tiarks moved, Madsen seconded to approve the agenda. Motion carried 4-0. No council member stated a conflict of interest with any agenda items.

Pingel moved, Dose seconded to approve the October 11, 2022, Regular Meeting minutes. Motion carried 4-0.

There was no one present to speak during the Public Forum.

Pingel moved, Madsen seconded to go into Public Hearing for Budget Amendment FY2023. Motion carried 4-0. Mayor Bardsley opened the public hearing at 6:03 p.m. Discussion by Sorlien on expense increases. Pingel moved, Madsen seconded to close the public hearing. Motion carried 4-0. Mayor Bardsley closed the public hearing at 6:05 p.m.

Discussion that Pottawattamie County would receive the funds via a voucher system for overseeing the bridge reconstruction. Pingel moved, Madsen seconded to Approve Acceptance of Offer of City Bridge Funding through Iowa DOT – Federal FY 2024 Funds. Motion carried 4-0.

Madsen moved, Tiarks seconded to approve Resolution 71-2022 Endorsing an Application for RISE Program Funding to Support Applicable Local Development by Reconstructing Portions of Magnolia Road Within the City and County Jurisdictions. Roll Call Vote: Madsen-Yes, Tiarks-Yes, Pingel-Yes, Dose-Yes. Absent: Forbush. Resolution 71-2022 adopted 4-0.

Rasmussen discussed that Magnolia Road would be widening East of the Railroad Tracks, with 3 lanes (includes a turn lane.) The road will taper just past the railroad. This winter will start talking with individuals. City thanked Pottawattamie County for their involvement and support. Pingel moved, Dose seconded to approve Resolution 70-2022 for Construction Agreement Between the City of Underwood and Pottawattamie County for a Secondary Road Extension. Roll Call Vote: Dose-Yes, Pingel-Yes, Tiarks-Yes, Madsen-Yes. Absent: Forbush. Resolution adopted 4-0. Wichman, Treantos and Rasmussen left.

Pingel moved, Tiarks seconded to approve the Second Reading of Ordinance 302 Amending Sewer Rates. Motion carried 4-0.

Pingel moved, Tiarks seconded to approve Pay App #1 for Charles Drive Road Reconstruction to Bluffs Paving for \$131,947.85. Motion carried 4-0.

No action taken on the Wastewater Treatment Plant. Engineer waiting for IA DNR to send final information and then will submit the Facility Plan to Iowa Department of Natural Resources.

Madsen moved, Tiarks seconded to approve Certifying Fieldcrest Phase 4, per Shiloh Properties request, to Pottawattamie County as of 12/1/2022. Motion carried 4-0.

Dose moved, Pingel seconded to approve December 2022 TIF payments to Links Snacks and Shiloh Properties. Motion carried 4-0.

Madsen moved, Dose seconded to approve the Alcohol License for KC Mart that was submitted to Local Authority by Alcoholic Beverage Division of State of Iowa. Motion carried 4-0.
