UNDERWOOD CITY COUNCIL REGULAR MEETING MINUTES -Tuesday, November 14, 2023

Mayor Dennis Bardsley called the regular meeting to order on Tuesday, November 14, 2023, at 6 p.m.

Roll Call: Forbush, Dose, Madsen. Pingel arrived at 6:18 p.m. Absent: Tiarks. Also in attendance: Powell, Sorlien, Jodi Bose, Alyse Petersen, Zoey Miles, Lola Paulson, Nick Hackett, Angie Maxwell, Delaney Cunningham, Dave Sturm, Claire Cook, Joyce Rodenburg, Lucas Bose, Kele Erwin, Keith Rodenburg.

Pledge of Allegiance recited.

Madsen moved, Forbush seconded to move Wastewater Treatment Plant Project to after recreation trail partial pay app and to approve the agenda with that change. Motion carried 3-0.

Forbush moved, Madsen moved to approve the October 10, 2023, regular meeting minutes. Motion carried 3-0.

During Public Forum, Tom Kallman-Manager of Regional Water, stated he would attend the December 12 meeting to discuss the water increase taking place in January 2024.

The shoulder rock was not salvable for part of the Recreation Trail-Phase 1. The fine grading will be done once it turns cold and the winter seed will be placed as well. Once that is complete, matting will be placed, and then the silt fence to be removed. Madsen moved, Forbush seconded to approve Change Order #2 for \$5,771.33 to Caliber Concrete LLC. Motion carried 3-0.

The winter grass seed will be placed when it's cold, as the current warm weather could activate it and then it wouldn't sprout in the spring. The retainage fee will be held until spring. The fire truck was moved to go out the south door. Dave Sturm, Engineer, stated that the area north of the fire station driveway was paved as thick as streets are and will handle the weight of the fire truck. Forbush moved, Madsen seconded to approve Partial Pay App #2 for \$223,803.63 to Caliber Concrete LLC for Recreation Trail – Phase 1. Motion carried 3-0.

There will be a tour of the Earling LEMNA system on Friday, November 17, for any council members or council elect members. This is the system type for the Underwood's Wastewater Treatment Plant Project.

Dave Sturm left at 6:18 p.m. and Jim Pingel arrived at 6:18 p.m.

Dose moved, Forbush seconded to approve Resolutions 23-11-02, 23-11-03, 23-11-04, 23-11-05, 23-11-06, 23-11-07 and 23-11-08: Authorizing Fund Transfers (Roads, Fire, Sewer, Other Public Safety) to Debt Service and Sewer Sinking for FY 2024. Pingel moved, Madsen seconded to approve Bond Attorney services for 2023-2025 sewer system improvement project. Motion carried 4-0.

Madsen moved, Forbush seconded to approve Resolution 23-11-09 to fix a date for a public hearing for Tuesday, December 12, 2023, at 6 p.m., on proposal to enter into a Sewer Revenue Loan and Disbursement Agreement and to borrow money thereunder in a principal amount not to exceed \$319,400. Fire/Rescue Department: There are 236 runs for the year. The new pickup arrived and got the second bid for the skid unit and lighting to go on the back. This will be paid for by the UVFR funds.

Administrator/Clerk: Newsletter for November/December 2023 will be combined and sent out/posted on 11/17. Iowa Rural Water Association nomination due. A business tab will be added on the city website and information request in the newsletter. Codification will need to start in 2024 to finalize in 2025. Strategic planning dates provided by McClure Engineering for April 2024 and will firm up dates in January. Seasonal employee to audit and create fillable building permit forms. Will complete basic orientation with

newly elected city council members before the next meeting. Handed out the Municipal Leadership Academy flyer from Iowa League of Cities and will register newly elected city council members and/or current council members if they wish to attend. The city will pay for the training.

Maintenance: Purchased a new fuel tank for the International dump truck, as there was a hole in the current one, and also purchased 3 batteries for it. On North Street on Sunday there was a water leak. There were 10 households who did not have water provided by Regional Water until Monday 11/13. Heading to Earling on Friday 11/17 at 10 a.m. to tour the LEMNA system. Once the process is approved Underwood's cell 2 will be divided and put into a dike, one for backup for high flow. It will double the sewer size the city can currently handle. A LEMNA topper will be placed on top of the area. Cell 3 will be filled and used for the building to house the equipment to run the LEMNA system. Question to be answered by the engineer in the future of what kind of heated building will it be – electric or natural gas. The two emergency generators at Lift Stations #1 and #3 were serviced by 3E last week. Council Committees:
