Madsen moved, Forbush seconded to approve the agenda. Motion carried 4-0.

Forbush moved, Dose seconded to approve the November 14, 2023, regular meeting minutes. Motion carried 4-0.

Tom Kallman, Regional Water Director discussed the price increase will occur beginning January 2024. The amount will be \$4.40 for the first 2,000 gallons of water, then 10.40 per 1,00 gallons over 2,000 gallons per month.
